## **What personal data we collect:**

We collect the following information when forwarded to us:

- a. Full name, e-mail address, telephone number and the company's postal address.
- b. In case of delivery, we also collect the delivery address details.

We expressly declare that we never use the collected data to send out unrequested information or inquiries such as e.g. newsletters, marketing letters or advertisements, unrequested offers.

## **What do we use your personal data for, why and for how long:**

We do use your personal data solely for business quotes, contracts and the realization of deliveries, and for all administrative or legal purposes in direct relation to these actions.  
Your personal data will not be used for other undertakings.

We will not retain your data for longer than we are obliged to by Norwegian Law. After that the stored data will be deleted, or prior to that if requested by you.

## **Security of your personal data:**

We strictly follow our security procedures in the storage and disclosure of your personal data and protect it against loss, destruction or damage. Your data is protected by using the SSL (Secure Socket Layer).

We do require any third party which your personal data is disclosed to to have appropriate security systems in accordance with the European General Data Protection Regulation in place.

- a. Equipment manufacturers and suppliers if the sending is dispatched directly to your location.
- b. Norwegian Customs and Financial Authorities.
- c. If necessary, forwarder and handling parties involved in the specific delivery.
- d. Our bookkeeper and our auditor, and if required legal or professional advisors.
